- a. Age (SSC)
- b. Relevant Proof of age relaxation, if applicable, as per the prescribed eligibility criteria.
- c. Educational Qualification as per Notification.
- d. Study Certificates from IV to X class / Residence certificate in case of private study.
- e. Integrated Community Certificate in case of claiming reservation.
- f. Local Status/ Migration Certificate for candidates who migrated from Telangana to A.P.
- g. Non-Creamy Layer Certificate as per G. O. Ms. No. 3, BC Welfare (C-2) Department, Dt. 04/04/2006 and G. O. Ms. No. 26, BC Welfare (C) Department Dt. 09/12/2013.
- h. Economically Weaker Sections (issued by the concerned Tahsildar/M.R.O/R.D.O) by candidates who opted EWS, as per G.O.Ms.No:73, GA(SER-D) Dept, Dt:04-08-2021.
- i. Disability Certificate in case of PBD candidates

2.The candidate should submit the above certificates with reference to the particulars furnished by him / her in the Online Application Form/Certificates, at the time of Verification of Certificates, failing which, their candidature shall be liable for rejection. The Commission has the right to disqualify any candidate, if he/she is not found eligible for any reason.
